Additional vendor space is available to the lessee party, at the time of the event, for an additional \$20 per table, per day, payable in full prior to delivery and set up of requested table(s).

The lessee agrees that all stands and display booths shall be self supporting and shall not require attachment to the premises, and that the lessee shall not do any damage to the walls, floors or any part of the premises, nor use any tack, nails or other sharp objects upon the walls, floors or fixtures of the premises, nor attach any display thereto

The lessee shall be responsible for any damage occasioned by his use of the premises, and shall not make or permit any waste or damage to the premises. The lessee agrees, to and shall pay all expenses and cost charged for the transporting, moving in, or erecting dismantling, moving out or any other such expense or cost related to the exhibition of the goods, services or products. The lessee shall secure any license or permit required of the city of Topeka Kansas and pays all license fees and taxes required by any municipal, state or federal regulation.
